# **PROSPECTUS**

#### **ELIGIBILITY**

Open to all artists within North America. All work must be current and original. Work must not have been previously shown with CAFA.

#### **MEDIA**

All fine arts media: painting, drawing, sculpture, photography, graphics, fiber, ceramics, printmaking, mixed media, video installations. No prints from original work. No furniture. Will accept all pieces that could reasonably be displayed within a gallery (i.e. no murals, outdoor sculpture, architecture, etc.). **No strict restrictions on dimensions or weight of pieces.** Use your own discretion and please ask us if you have any questions.

#### **ENTRY REQUIREMENTS**

All work must be submitted online. No shipments or carry-in of work will be allowed. All work must include the artist, title, medium, dimensions, and be priced or marked NFS. CAFA reserves the right to refuse to accept any work deemed inappropriate to the exhibit.

Please do not include the frame of the artwork in your submitted images. All of the pieces in our virtual gallery will be displayed without a frame. 2D work must only submit one image. We ask that 3D works submit several different perspectives if the artist would like the piece to be viewed entirely.

When submitting your work through our online entry form, please read all of the text thoroughly to be sure that you are meeting our requirements.

#### **ENTRY FEES**

CAFA Members: \$40 Membership + \$25 for up to three entries

Non-Members: \$30 for one entry, \$35 for two entries

#### **NOTIFICATION**

Participating artists will find results posted on the CAFA website by July 4 and be notified by email. **DO NOT CALL CAFA FOR RESULTS.** 

### **ACCEPTED WORK**

Up to two pieces of accepted work per artist will be displayed in the exhibition. All work will remain displayed on the website until September 5, 2020.
